

PRIVACY - DISCLAIMER

The Province of West Flanders respects the privacy of the users of its website www.gonewest.be. The collection of personal data via www.gonewest.be and the use of that data by the Province of West Flanders is in compliance with the provisions of the Belgian Law of 8 December 1992 on the protection of privacy.

Recording personal data

Visitors to www.gonewest.be can register via the site. The following types of data may be recorded:

- Identification details such as name, address, telephone number, ...
- Electronic identification details such as IP addresses, cookies, ...
- Personal characteristics such as age, gender, personal interests, ...

The data that visitors provide on registration is recorded by the Province of West Flanders in the database of the Province of West Flanders, Provinciehuis Boeverbos, Koning Leopold III-laan 41, 8200 Sint-Andries. In accordance with the protection of privacy law of 8 December 1992 and its later amendments, you have the right at all times to check your data, change it if necessary, and, if desired, to have it deleted.

Users who register via this site agree to the use of their personal data in accordance with the privacy policy set out below.

Use of data for internal purposes

The Province of West Flanders may use the collected personal data for various processing purposes, such as: providing information on the cultural programming of the GoneWest editions for the years 2014 to 2018, including any changes to this programming; sending the GoneWest newsletter; providing people who are registered as participants for a specific GoneWest event with information about that event, including any changes; providing information about competitions and their results; providing information about other services by the Province of West Flanders; statistical research; work planning; the prevention of fraud and other criminal offences.

The users of the website have the right to object to the use of their data at all times. This right of objection can be exercised by sending an e-mail to gonewest@west-vlaanderen.be or by sending a letter to the database operator at the following address: Province of West Flanders, att. Cel GoneWest, Provinciehuis Boeverbos, Koning Leopold III-laan 41, 8200 Sint-Andries. Your objection must always be accompanied by a copy of your identity card. Your data will then be removed from the database.

In all communications via e-mail, there is an option to have your name deleted from the mailing list for future electronic communications.

Disclosure of data to third parties

If necessary, the data that you provide may be made available to legal or police services and, to the extent necessary for the organization of events within the cultural programming of GoneWest, to the insurance company used by the Province of West Flanders.

Inspection and correction of data

The user or subscriber has the right to inspect his recorded personal data and to have it corrected, if necessary. To do this, please send an e-mail to gonewest@west-vlaanderen.be or send a letter to the database operator at the following address: Provincie West-Vlaanderen, att. always be accompanied by a copy of your identity card. You will then receive a print-out of the data held on you by the Province of West Flanders.

Cookies

On each internet visit to our website, the Province of West Flanders will install cookies on the visitor's computer. Cookies are pieces of information placed on the hard disk of your computer each time you surf to www.gonewest.be. The purpose of these cookies is to allow easier use of the website (for example, so that certain information on access control does not have to be repeated).
